Cook Inlet Maritime Risk Assessment Advisory Panel to Meet

The Advisory Panel of the Cook Inlet Risk Assessment (CIRA) project will hold its next meeting on Monday, April 23, 2012, at 1:00 p.m. The meeting will take place in the Chesloknu Conference Room of the Dimond Center Hotel, 700 East Dimond Boulevard, in Anchorage, Alaska.

The primary agenda item for this public meeting is the presentation of the **Spill Baseline and Causality Study Report** by the project contractors, The Glostén Associates, with Environmental Research Consulting. This Study is Task 4 of the Cook Inlet Maritime Risk Assessment project. A review of Action Items will also take place, and the Advisory Panel's next meeting will be set as well.

The Glostén Associates, in collaboration with Environmental Research Consulting, have prepared the draft **Spill Baseline and Causality Study Report** for the Cook Inlet Maritime Risk Assessment Project (CIRA). The study builds from the Vessel Traffic Study that was completed in February 2012. The intent of the Spill Baseline and Causality Study is to:

- Estimate the spill frequency, and project spill size distribution, by vessel type
- Develop an oil spill baseline over the 10-year study period, based on projected movements of oil and the estimated average spill rate
- Characterize spills from high-risk accidents, and
- Provide accident scenarios based on the five most dominant accident types
